

**Bertrand Farm
Community Sponsored Agriculture
Non-Working Membership Agreement 2017**

The following list details the contractual agreement between Bertrand Farm Inc. (BFI) and non-working CSA members.

1. Each Non-Working CSA member will contribute \$450. (new ¾ size option is \$300.) for a full membership to be used for the purchase of needed seed, soil amendments, fertilizers, equipment maintenance, tool replacement, hired help and any other materials for the 2017 growing season.
2. BFI will provide a minimum of one bushel of fresh, organically raised produce each week beginning the first week of June, 2017 and lasting 15 consecutive weeks thereafter until September 16, 2017. There is one rain date built into the schedule. Variety will increase as the growing season matures.
3. Member agrees to pick up box of produce at Bertrand Farm, 3575 W Bertrand Rd, Niles, MI on Saturdays between 11am – 1pm or at Good Shepherd Montessori School, corner of Jefferson and Eddy in South Bend, Wednesday between 5 -7pm. BFI is not responsible for produce that is not picked up in a timely manner No refunds for missed days.
4. In the event of a long growing season, produce will be available for purchase each week after the contract period until harvest stops.
5. As part of this binding contract, Member agrees to jointly, with BFI, assume any loss of produce due to weather or uncontrollable circumstances, not to exceed initial investment of membership contribution.
6. BFI will grow all produce under the guidelines required for organic production imposed by OMRI , the Organic Materials Review Institute.
